

Exhibitor Liability Insurance Program

As a standard requirement for all of our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance coverage is not optional.

This insurance must be in force during the lease dates of the event October 17-20, 2022 naming National Association of Broadcasters (1 M Street SE, Washington DC 20003) as the certificate holder. The following must be listed as additional insured: National Association of Broadcasters, Jacob K. Javits Convention Center and Freeman.

National Association of Broadcasters has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.
